4.2. Forbidden zones:

The map and local zones of forbidden zones will be announced in LASF internet page. It's strictly forbidden to stay on forbidden roads or local zones for all the participants of Rally.

It's officially declared by LASF and Rally organizers appointed members that all the offenders of the rules will be eliminated from LARC stage.

The map of forbidden roads or local zones (annex. No.5) will be published in internet portals: www.lasf.lt, www.300lakesrally.lt from 2010-06-22.

4.2.1. Persons mentioned in point 4.2. who want to cross the forbidden roads must inform LASF and organizer about their purposes beforehand by e mails: <u>rasa@lasf.lt</u>, <u>info@300lakesrally.lt</u> and to get the certified permittion by e-mail.

All participants of LARC round IV are able to drive on A6 highway, which is included into forbidden local zone, without "300 Lakes Rally" organizers permission from 2010-07-08 till 2010-07-12.

V. ELIGIBLE VEHICLES

5.1. It's allowed to take part in LARČ 2010 stage credit with automobiles from international groups ",N" and A" and national groups ",S" and ",L". All the automobiles should correspond all the requirements of LARČ Regulation article 12 - 14.

5.1.1 Racers from NEZ Rally Championship can take part in the Championship with the automobiles which have FIA homologation or the cars should correspond all national technical requirements of their own country and the requirements of NEZ Rally technical committee.

5.1.2 Automobiles which have valid international homologation and corresponding all the requirements of FIA technical Regulation can take part in Baltic Rally Championship. Also the automobiles that correspond the national technical Regulation of the country which has issued the sport licence to the participant.

5.1.3 It's allowed to take part in Rally stage with the automobiles that correspond all the technical and security requirements mentioned above.





VI. ENTRIES

6.1. All drivers, holding valid driving license and the competitor's license issued by the LASF or other parental ASN (valid in this event) may take part in the rally.

Participant younger than 18 years is able to take part in the LRC event only by individual LASF rally comitee decision.

6.1.1. Duly filled in and signed Entry Forms together with a copy of entry fee transfer document must reach the Organiser before 2010-08-02 (Monday).

Data about the co-driver may be submitted during administrative check.

6.2. Under supplementary regulations of Baltic Rally Championship, all Entry Forms for participating in Baltic Rally Championship have to be send to organizers just once - before participating in BRC round for the first time (annex. No.2).

6.3. Administrative checks:

The inspection of documents will follow together with dividing of Road Books.

7.2. Partial fee repayment:

If the crew which have payed the fee but have a justifiable reason not to participate in Rally will receive the repayment of 50% of start fee. If race is revoked because of "Force majeure" conditions, participants will get the repay of 50% of start fee.

7.3. Insurance:

7.3.1. Each participant should have valid vehicle civil liability insurance policy or "green card".

7.3.2. Running track participants liability for third party damage caused by the accident, the person (or) property, arising as a result of the accident, hedges the organizer.

Participating race drivers are not third parties.

7.3.2. Running track participants liability for third party damage caused by the accident, the person (or) property, arising as a result of the accident, hedges the organizer.

VIII. ADVERTISING

8.1. The positioning of the advertising material provided by the Organiser is presented in Appendix No.1 of Regulations of the Lithuanian Rally Championship and this advertising is mandatory (Supplementary regulations Appendix No.7).

IX. PRINCIPAL OBLIGATIONS

9.1. Checking of driver's helmets and driver's equipment shall be performed during the pre-start scrutineering.

9.2. All violations made by the crew during the reconnaissance will be registered by the judges of the fact in crew's reconnaissance cards. The list with the names of the judges of the fact and their authority will be published on the official notice board and signed by the rally director.

9.3. Reconnaissance:





9.3.1. The reconnaissance of SS4/5 and SS6/15 is allowed on 2010-08-12 (Thursday) from 16:00 p.m. till 21:30 p.m.. SS4 identical with SS5 and it will be allowed to pass only as one special stage twice. Reconnaissance with SS6/15 is allowed only by foot.

The reconnaissance with other part of the route is allowed on 2010-08-13 (Friday) from 8:00 a.m. till 19:00 p.m. For those who haven't done recconaissance of SS4/5 and SS6/15 on 2010-08-12 (Thursday), will be allowed to do that on 2010-08-13 (Friday) from 7:00 a.m till 8:00 a.m.)

It will be allowed to pass every special stage not more than 2 times. SS8 is identical with SS10 and it will be allowed to pass them only as one special stage.

SS14 comes into section of SS11 and it will not be allowed to do recconaissance with SS14 separately. The reconnaissance of SS14 will be performed driving on SS11 stage, separately indicating SS14 finish – not more than twice.

The quantity of reconnaissance on special stages will be controlled by fact judges and surveillance equipments.

9.3.2. During the reconnaisance crew must drive on special stages without cousing danger or inconvenience for people living near by the special stages. Driving of the crew in the opposite direction is strictly prohibited on the special stages. Persons appointed by the organizer, police and GPS surveillance equipments will control the speed during the introduction with the trace which can be recreased by appropriate signs presented in road book. The list of persons appointed by the organizer will be publicly announced in time of administrative commission.

The use of antiradar is forbidden.

Speeding till 10 km in time of recconnaisance with the special stages will not be kept as infringement and will not be fined.

All the traffic violations done in time of recconnaisance with the special stages according to the reports of fact judges, police and GPS data will be fined:

First violation:

- when speed exceeded till 30 km per hour - fine 20.00 Lt for each exceeded km per hour;

- when speed exceeded till 50 km per hour - fine 50.00 Lt for each exceeded km per hour;

- when speed exceeded more than 50 km per hour – it's forbidden to start;

Second violation:

- when speed exceeded till 30 km per hour - fine 40.00 Lt for each exceeded km per hour;

- when speed exceeded till 50 km per hour - fine 100.00 Lt for each exceeded km per hour;

- when speed exceeded more than 50 km per hour – it's forbidden to start;

Third violation:

- forbidden to start;

All the other violations will be announced to rally commissioners and they will fine according LASK article No. 152. National federation will also be informed.

Notice: 10 km per hour permissible bias will be minused from speed exceeded.

9.4. Reconnaissance vehicles:

It's possible to do recconnaisance with special stages only by the automobiles which are registered with the organizer and should meet the requirements of T-2010 point 14.3 and where should be <u>12V cocket</u>.

9.5. The way to receive and use GPS surveillance equipment:

In time of administrative commission the screw gets GPS surveillance equipment. The participant is fully in charge for the safety, installation, operating and returning back the equipment. The equipment must be installed into standard 12V socket and must be placed into a visible location in order the judges easily could see and examine it. GPS equipment has inner accumulator which is intended to register the time of equipments interconnection into 12V net, therefore not-recording the GPS data about the introduction because of the fault of crew (for example – power turned off)





will be treated as a rough violation. That will be announced to the commissars who will strictly fine according LASK article No. 152 (annex. No.7., Fine Table). GPS equipment must be carried back on the second day (2010-08-13) together with the card of introduction with the route. The protocol of GPS stock data is treated as unquestioned fact about the violations during introduction with the route. Person responsible for GPS equipment: Dmitrij Mironov, tel. +37068687863.

9.6. Test Stage (Shakedown):

Shakedown stage may be driven along not more than 3 times. Applications for test stage are accepted till 2010-08-02 (annex No. 1). All crews are allowed to introduce with Test Stage (Shakedown) just two times. The quantity of reconnaissance with Test Stage will be inspected by GPS surveillance equipment installed in reconnaissance vehicles.

9.7. The participants must bring the introduction with the route card to organizers secretariat till 2010-08-13 (Friday) 19:30 p.m. If this requirement will not be pursued the participants will be fined according LASK article No. 152 by SKK (annex. No.7, Fine Table).

9.8. All the fines should be payed till 2010-08-14 (Saturday) 10:00 a.m.

9.9. Automobile sport clubs, claimants, their members and other natural and legal persons who want to organize the VIP guest zone in "300 Lakes Rally 2010" must have the written agreement from the organizer.

X. TYRES

10.1. In time of the introduction with the route the participants should use tires which are certificated to drive on public roads in summer season and corresponding road traffic regulations requirements (T-2010, point 14.3.13).

10.2. The amount of tyres and replacements are not limited.

XI. RUNNING OF THE RALLY

11.1. Official race time – time according the signals of Lithuanian radio.

11.2. Rally start:

Date: 2010-08-14 (Saturday) Time: 12:00 a.m.

11.3. Official start schedule will be announced on the official board of race.

11.4. Participant time control cards will be collected (issued): TC0, TC5A, TC5B, TC6C, TC6D, TC14A, TC14B, TC15A.

11.5. Possible earlier Check-in: TC5A, TC6A, TC6B, TC6C, TC14A, TC15A.

11.6. Crews retired from the race should inform rally headquarters (Clerk of the Course Gražvydas Smetonis tel. +37068756218 or Competitors Relations Officer Tomas Majauskas tel.: +37061928444) about the reasons, place and time. They are also supposed to return back the time card in the nearest post or to return it to the passing "broom" automobile and to take off start numbers. If the crew will ignore those requirements, they will be fined.

11.7. In case the crew gets into the accident, spectator or crew member is hurt, the crew member is immediately supposed to inform about the accident by "SOS" signs not less than 3 crews driving after (T-2010, points 19.9.2 – 19.9.3) and Clerk of the Course Gražvydas Smetonis tel. +37068756218 or Competitors Relations Officer Tomas Majauskas tel.: +37061928444.

The screw, breaking "OK"/"SOS" requirements of signs usage, will be fined by the decision of commissars according LASK point No. 152.

11.8. The crews must follow the judge's instructions for running through the start / finish arch.

11.9. Start procedure in special stage:

In all GR start is executed with electronically equipments.

Time card is given to the crew 30 seconds before the predictable start.





25 seconds before the start remaining time will be countable on electronic scoreboard.

First red light signal lights on 55 sec, second red signal on sec 56 and so on. Last red signal (fifth) on 59 sec. Next minute (00 sec) all five red light signals go out and the crew must start.

Jump start is registered by electronic ray, the system is showing the identification of jump start for 5 sec. Decision about jump start is carried out by the judge and is fixed in start protocol.

It there is no electronic equipment or it does not work, the start procedure done according the requirements of T-2009, point No. 19.5 (19.5 – point of general FIA requirements). Start judge must inform the crew if start procedure is done without electronic equipments.

11.10.Rally finish podium procedure.

Participants entering the TC15A PF, have to place rally cars in line by the directions of the officials to go through the finish podium of the rally. Crew participation in the rally finish podium procedure is mandatory. The penalty for violation of this procedure 200 Lt.

11.11. Super Special Stage (SSS).

The Super Special Stage will be driven twice. Surface: 100% (2 km) gravel. The competitors will have to drive the SSS in pairs. When the last two pairs of competitors will finish the SSS, according to instructions of scrutineers they will have to drive near the scene and take part at the press conference.

11.12. Service:

Service zone for participants will be opened from 2010-08-14, 6:00 a.m.

11.12.1. In time of race sports automobiles service is allowed only in service parks that are indicated in road book. Refuel is allowed only in fuel filling area. After SS8 and SS12 - the additional refueling, where the competitors will be able to refuel by their needs.

11.12.2. In service zone it's forbidden to wash sports automobiles, their accessories and systems which use technical oils (engines, gearboxes, reducers, buffers).

11.12.3. Not more than 2 service cars are admitted into the park (application for service automobiles in annex No.1). Stickers given by the organizer must be sticked on the window of service car. Those who will not keep to those requirements will be fined. Automobiles for introduction with the route are not allowed to the service park.

11.12.4. Participants trailers and other technology should be left in Zarasai bus park territory, Statybininku str. 2.

11.12.5. Water resistant floor (min. 4x4 m) must be spread under the sports car in service zones. It's required to have contents to collect the effused fuel in all fuel filling zones. When using pumps in fuel filling, protective cranes or valves must be equipped at the ends of hose.

11.12.6. After the maintenance all service zones must be left tidily, all rubbish must be put into containers of service zones.

In case of breach of this point the service zones judges will inform competition chief about the violations and the crew will be fined.

11.13. Regrouping:

There will be three regroupings during rally - startup procedure conversion according the results - SS 1-5 (after SS5); SS 1-6 (after SS6); SS 1-14 (after SS14).

11.14. Parc Ferme (PF) will be pursued:

- after SS5 at Great island of Zarasas lake, 2010-08-14

- after SS6, 1st day rally finish on 2010-08-14 (Saturday) till 2nd day rally start on 2010-08-15 (Sunday), Valstiečių str. 14, Zarasai, AB "Rytų skirstomieji tinklai" protected area

- after SS14, at Great island of Zarasas lake, 2010-08-15

- after SS15, at Great island of Zarasas lake, 2010-08-15

The requirements of T-2010, chapter XX, is applied for PF

XIII. PROTESTS AND APPEALS

13.1. All protests shall be submitted following the requirements of Art.171 -179 of the LASC.

13.2. All protests shall be filed together with the deposit of 500 Lt.

13.3. In case the protester requires dismantling of parts of the vehicle, the person lodging such a protest must pay the additional deposit as specified in Art.35 of the Rules of the Lithuanian Rally Championship 2010.

13.4. Appeals shall be filed following Art.180-191 of the LASC.

13.5. Appeal fee is 2000 Lt.

15.1. "AWD general personal I drivers", "AWD general personal II drivers" and "2WD general personal I drivers" and "2WD general personal II drivers" in credits I place winners will be presented with LASF diplomas, Organizers prizes and cups if such are established.

15.2. "Class personal I drivers", "Class personal II drivers" winning I-III places in credits, will be presented with LASF diplomas, Organizers prizes and cups if such are established.

15.3. Teams winning I-III places in LARC stage team credit will be presented with Organizers cups and LASF diplomas.

15.4. The crew winners of Rally "300 Lakes Rally 2010" in general credit will be presented with Zarasai district mayor cup.

15.5. The organizer and supporters have the possibility to present the participants with extra prizes discretionary.

XVI. AWARD CEREMONY

16.1. Award ceremony will proceed in the Great Island of Zarasas lake on 2010-08-15, 21:15 p.m.16.2. All the crews must take part in award ceremony. In case the crew is not participating in award ceremony they will be punished a fine of 200 Lt and will lose the right to award prizes.16.3. The list of awards will be hanged on the official Championship informational board.
